WINTER CONCERNS IN FALCON RIDGE

ICE BUILDUP: Here is what the City of Centennial will do for ice build up which has been a perennial problem around the north end of Emerson Street near the entrance. Once they receive a work request at 303-325-8000, they will evaluate if it meets ice removal criteria which is: 1) it is causing a traffic hazard by ice forming in the travel lane or 2) is forcing water onto the sidewalk which is then freezing. If the situation meets the criteria, they will send a mechanical ice chopper based on the priority of the problem in the system. Ice build up is a common problem in Centennial, so action may not necessarily be immediate. This is not an automatic process. Someone from the neighborhood has to call and ask for it. So, if you live near or use the north entrance and notice hazardous ice build up, please call. For more details, go to http://www.centennialco.gov/Public-Works/ice-removal-pilot-program.aspx

SHOVELING SIDEWALKS: Although it is not required by the City of Centennial to shovel your sidewalk, we have plenty of folks out walking and kids going to school. It is much appreciated to have sidewalks cleared in a timely manner. And, extra appreciation for those who take care of a neighbor's walk when needed.

STREET PLOWING: Residential streets are considered Priority 3 streets in Centennial and are maintained only when authorized by the City Manager. The City Manager will consider the following guidelines in determining when to authorize Priority 3 snow route plowing: Forecasted street snow accumulation is six (6) or more inches; Forecasted temperatures are below freezing for an extended period after the storm; Forecasted additional snow events within the next 24-48 hours.
